# When is a grading permit needed?

- 50 CY cumulative
- 20 CY cumulative in a water course
- 1 acre vegetation removal

# Exemptions

- Exempt Grading
- Agricultural Grading
- Alternative Review Program – RCD

# Alternative Review Program

- Grading Permit – in lieu of County permit
- Services Provided
  - Engineering design/review – NRCS Standards
  - Environmental review
  - Erosion control assistance
- Eligible Projects
  - Agricultural projects – roads, benches, streambank protection, conservation/restoration
